## Certifications in packaging.

### We provide certification for you.

#### Desiccant bags.

High-quality desiccant bags protect sensitive industrial goods from humidity in transit and during storage. Basis for certification: DIN 55473 “Auxiliary means of packaging – Desiccant bags”.



#### Corrugated board.

Due to the growing trade with products from all over the world the requirements for packaging and thus also for the corrugated cardboard are becoming ever more demanding. Basis for certification: DIN 55468-1 “Packaging materials – Corrugated board – Part 1: Requirements, testing”.



#### Pallets from polyethylene/ EURO H1 hygienic pallets.

The safe and hygienic transport of meat and meat products is becoming ever more important.

Basis for certification: DIN 55423-6 “Transportation chain for meat and meat products – Part 6: Pallet made from polyethylene. Construction, requirements and test”.

The “plus” represents additional, more stringent requirements and monitoring of the manufacturer's quality assurance system and thus it is indicative of the high quality of the certified products.



This DINplus certificate enables the holder to apply for a licence to use the GS1 mark from GS1 Germany. Basis for certification: GS1 Profile of requirements for EURO H1 hygienic pallets.



#### PEFC – Products from sustainable forestry.

Product chain certification (Chain of Custody) ensures that the source of the raw materials and the flow of materials from the purchase of the raw materials to the sale of the final product has been documented and monitored from start to finish. Basis for certification: normative document PEFC ST 2002.



#### Products from recycled material.

This certification is suitable for products made from recycled material, e. g. plastics. The focus of the certification is the assessment of the system for traceability and thus for the calculation of the recycled material content in the end product. Basis for certification: DIN EN ISO 14021 “Environmental labels and declarations” and DIN EN 15343 “Recycled plastics”.
